## 4) GREEN AND INCLUSIVE COMMUNITY BUILDINGS GRANT APPLICATION -

Stephen McKendry-Smith provided a document outlining several options for the roofing and insulation project for consideration. The option agreed upon will be included in our grant application to the Federal Government. He reviewed the software that was used to prepare the models. Other grants include the Faithful Footprints from the United Church Faith & The Common Good and Efficiency Manitoba. There is no commitment on our part to proceed with the project as submitted if we do not obtain funding. Option A would fix the roof of the sanctuary, add insulation to both buildings, replace all existing furnaces with Air Source Heat Pumps and install solar panels on sanctuary roof. Total cost would be \$400,000 with our portion being \$35,000 if we received full grants. Payback in years would be about eight years. Option B would delete the solar panels. Cost would be \$370,000 with our portion being \$29,000. Payback would be 12 years. Option C would delete the insulation to CE building portion. Cost would be \$300,000 with our portion being \$21,500 with full grants. Payback would be five years. All three options provide a decrease of over 90% of our greenhouse gas emissions. A discussion followed. Items discussed were solar panels, annual savings from the renovations, maintenance, stucco repairs needed, air flow and the need to replace furnaces soon. The heat pumps would provide air conditioning as well. Also discussed were how big a project we want to take on and whether we want to spend a large portion of the Building Fund. The Building Fund currently has \$33,000 over the amount required for the United Church loan.
