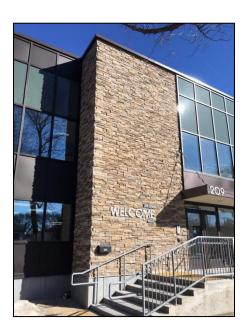

MINISTERS' REPORT

At the end of the 2020 Annual Report, we wrote: "inasmuch as the story of 2020 was quite complex, 2021 can be a hopeful song filled with grace and love as we continue to journey together."

As we reflect on 2021 TMUC certainly sang of grace and love as we journeyed together! 2021 brought new and different Health Orders and Immunization and Vaccines. 2021 brought more hours of ZOOM, hundreds (if not thousands) of emails, countless phone visits, and even a few limited opportunities for visits in hospitals and Care Homes.

As Health Orders allowed, and Council wisdom discerned the time, what joy there was for the first opening of the doors to public worship in our beloved Sanctuary.

On September 26, 2021 at 10 a.m. we said aloud the words of welcome and blessing and acknowledged the sacred land on which we live. We remembered our role as Treaty People and as People of Faith, worshipping together. We donned fresh medical quality masks and we dared to sing 'Lord, Prepare Me to Be a Sanctuary' and 'Come In, Come In, Come in and Sit Down' and more. It was glorious!

And, we were careful. We were small in number for each and every week that we gathered for in person worship. And, we continued to imagine and re-imagine, to prepare and revise, to work with each other and our AMAZING music team, then to organize, assemble and provide, online resources. Our growing community who continue to find that online worship is safest and best for them have followed these services, viewed them and engaged with the Spirit with us.

2021 also gave us opportunities for some weddings (3), funerals (15) and baptisms (6). Each one was unique as we pivoted to the Health Order of the day. And, in each one, we all shared in a living song of God's grace and love.

And we lived in hopefulness with the return of a very careful and quite neatly orchestrated Messy Church in December (each other gathering was on ZOOM), and plans for in person worship on Christmas Eve. However – hopefulness had to pivot! And, we are grateful for the wisdom of the Council and Executive, the dedication of the Music Team and the Choir, and the skill of the Tech Team in making it possible for us to post and share worship resources for another Christmas Eve at Home.

And now, the song goes on. God's grace and love continue to echo in our congregation and community. We bear witness to the living Christ embodied in each one of us. We bear witness to God's love for us as we love one another.

TRANSCONA MEMORIAL UNITED CHURCH 68TH ANNUAL CONGREGATIONAL MEETING MARCH 7, 2021

1. Call to Order

The 68th Annual Congregational Meeting of Transcona Memorial United Church was held by ZOOM video-conference on Sunday, March 7, 2021. Notice of the meeting was given via e-mail to all members for whom we have e-mail addresses, which is 88% of the congregation's membership. The meeting was called to order by the Chairperson Audrey Lumsden at 10:30 am.

2. Appointment of Secretary for the Meeting

MOTION: Moved by Bonnie Scott/Laura Fraser-Schau, "That Susan Copeland be appointed the secretary for this annual meeting." CARRIED.

3. Speaking and Voting Privileges

MOTION: Moved by Alan Gershuny/Carol Favoni, "That all members and adherents in attendance shall have speaking and voting privileges at this 68th Annual Meeting." CARRIED.

4. Approval of Minutes

MOTION: Moved by Shelley Schau/Cindy Ostapyk, "That the minutes of the 67th Annual Congregational Meeting dated Sunday, November 29, 2020 be accepted as printed."

CARRIED.

5. Celebration of 2020

Audrey Lumsden sent a big thank you to Lynn Measner for preparing the annual report and to Karen Ilchena for posting on the web site. She indicated it was a very difficult year with the church building closed due to the pandemic. But we still managed to carry on the

work of the church by doing things differently. She reviewed the reports and highlighted the Food Bank report and the list of donors to the Food Bank. She also noted that the nursery school is coming up to 40 years of operation. She thanked the ministers, staff and congregation for their support during the year.

MOTION: Moved by Karen Ilchena/Don Heinrichs, "That we receive all reports as printed in the Annual Report, pages 1-4, 7-37." CARRIED.

6. Financial Results for 2020

Cindy Ostapyk thanked everyone for the support during the year. We had a surplus of \$85,000 for the year. On the income side we had the plant sale, dinner theatre donations, bequests, wage subsidies and grants from the governments because of the pandemic and support for the Food Bank. On the expense side the salaries were down as we did not have an office administrator and youth point person for most of the year. The Exchange Group has reviewed the financial statements and the results are as reported in the annual report. She is hoping for the same support this year.

MOTION: Moved by Cindy Ostapyk/Don Heinrichs, "That the Financial Statements for 2020 be approved as printed in the Annual Report." CARRIED.

Cindy Ostapyk thanked Don Heinrichs and Adrian Measner for the extra work involved in obtaining the government grants and wage subsidies, and for preparing the monthly reports.

7. Appointment of Auditor

MOTION: Moved by Cindy Ostapyk/Donna Hadaller, "That the Exchange Group be retained as auditors for the 2021 fiscal year." CARRIED.

8. Looking to the Future

COVID-19 Pandemic Update: Carol Fletcher provided an update on the COVID-19 pandemic and the implications for the coming year. She noted that a re-opening plan has been prepared by Sylvia Jansen and Karen Ilchena but will depend on the public health orders. In our sanctuary, with a 2-meter spacing requirement, our capacity is very low. We can accommodate only 20 individuals with a slight increase in the number with family groups that can sit together. In response to a question about cleaning supplies that may be needed, she noted that we do not know at this time if the requirements will be for air exchangers or sanitizing of surfaces. It was agreed that we would not be in a hurry to open. She also noted that some of our members with mobility issues have found the online services beneficial and it has connected us with other congregations around the world. Providing the on-line service in the future will need to be studied.

<u>Summer Gathering</u>: Carol Fletcher advised that we will continue doing what we are doing and perhaps have a street party outside the church during the summer. Cathie Morgan-Matula, Michelle Lamoureux, Vicky Low and Brenda LeBeau volunteered to serve on a planning team.

Darrell Fierheller thanked the ministers, Esther and Emmett, the music team and all the people who worked hard over the year on the on-line service. A round of applause was given.

9. Approval of Proposed 2021 Budget

Adrian Measner advised that in preparing the budget the assumption was made that we would still be in the pandemic for the whole year. For the General Fund they projected that the givings would stay the same, the wage subsidy would be less and the bridge grants would stay the same. Fund raising would be low and cleaning would be half of the normal amount. An increase in salary was provided for ministers and staff and hydro and insurance amounts were increased. Food Bank amount would be less. The deficit would be \$14,522. For the Building Fund they have provided an expenditure of \$8,200 for the interest on the loan. The Ministry Fund includes a small amount of givings and an expenditure of \$7,000 for audio-visual equipment for the lower levels. If we were to come out of the pandemic our cleaning expense would double and we would need an office administrator. This would result in a \$3,000 per month increase in expenses. He also noted that we have a couple of big projects that will be required in the near future: the replacement of the roof on the sanctuary and replacement of aging furnaces. The Building and Property Team are also looking at putting more insulation in the sanctuary roof.

MOTION: Moved by Adrian Measner/Bob Kirkhope, "That the Proposed Budget for 2021 be approved." CARRIED.

Adrian Measner, Cindy Ostapyk and all the other individuals involved in the financial work were thanked for all their hard work.

MESSAGE FROM THE CHAIR OF THE COUNCIL

Let us trust God to grant us wisdom, mercy and faith

The year 2021 has in many ways been a continuation of 2020 in the work and life of our Transcona Memorial United Church congregation due to ongoing COVID and ever-changing health regulations which have continued to be met with new ideas of how to best meet ministry. COVID has and continues to strongly impact on us being able to meet in person as a congregation, to plan for our congregation, as well as ministry having to change to meet our needs, including our ability to open our doors to the community as well as important fund raising for TMUC.

ZOOM technology became prime in sharing ministry to our congregation and beyond over the past year. This also applied to TMUC Council as well as various committees who met to carry out and support the efforts of TMUC. UCW has utilized social media to help keep members in the know and an opportunity to share with others in the UCW.

Council as well as many individuals who volunteer have continued to support our congregation. We are grateful for this assistance! Over the past year, we had leadership from Adrian Measner in applying for grants and the financial supports which were short term responses to the COVID impact. A sincere thank you to Breanna Drennan-Bilyk and the team who planned and helped with the plant fund raiser, something that many individuals looked forward to and supported. Many persons were generous in supporting the school supply dropoff in September to help newcomer children in the River East Transcona School Division have access to needed supplies. We also had the fund-raising metal drive which was held at the church and organized by church members. Although we were unable due to COVID to have the Christmas hamper program on site, many donated to the Transcona Food Bank and the Plessis Family Resource Centre. Environmental needs have continued to be identified and led by Stephen McKendry-Smith as we seek grants and solutions to update our aging church. The Food Bank continued to answer the call for food security for many residents of the community, including many children being recipients. To you as the congregation for your financial support and the volunteers who give of their time and talents, a very special thank you.

One of the Council's ongoing discussions has been the governance structure of the TMUC Council. It is obvious that the current model is not meeting our needs, thus a proposal will be presented at the Annual meeting to try another model. Regardless we are still in need of ideas and suggestions for now and in the future.

As Council reviewed the health regulations and established a vaccine policy, the congregation was invited to returned to in-person services in September, 2021. In-person response was there albeit with limited numbers and brought to an abrupt halt for the Christmas Eve Service with the Omicron virus taking over the world with many persons stricken locally including increased hospitalizations and deaths. Although some of the community groups had just begun to return, i.e. Guides, Scouts, they too had to stop their activities.

We continue to be grateful to our ministerial staff who have continued being there in leadership as well as being creative in bringing worship to the congregation virtually. To our Ministers Jeff Cook and Carol Fletcher and their puppet partners Esther and Emmett, a special thank you for your creativity as well as reaching out to and being there for congregation and others in the community who are in need. We are grateful for the music contributions of Crystal Schau,

Cheryl Jackson, Lynne Mavins and those who have participated including all of the technical work and support required to carry out this ministry. Thanks to Karen Ilchena who has done the outstanding work of website management. A special thank you to Brenda LeBeau for her efforts for Sunday School and Messy Church. Messy Church has been very successful and although again limited in person, the work of Carol and those connected to the program has been very important.

On behalf of the TMUC Council, staff and congregation, a very special thank you to Lynn Measner who has volunteered for the past two 2 years to complete the necessary administrative duties meeting the needs of the congregation. Thank you does not seem adequate for taking on this responsibility. We are very grateful Lynn.

Thank you to all Council members and the various teams for your time and assisting in keeping our church going. We accepted and acknowledged the resignation of Laura Fraser-Schau as chair of Ministry and Personnel earlier this summer. Laura chaired during a difficult time of adjusting from the normal to a period of COVID. A special thank you to Building and Property Committee who have been there to keep the church functioning in terms of the day-to-day operations and needs.

As I complete my term as chair I am always reminded that we are a community of faith and followers of Jesus and to know that God is with us always. We are not alone, we live in God's world. May we be with each other always in prayer and reaching out to each other.

ADMINISTRATION and SHARING TEAM

Like all other teams, the Administration and Sharing team had another interesting year in 2021. While we continue towards our main purpose - which is to motivate and educate the Congregation in their responsibility as stewards of time, talent and money, the journey this year continued to be challenging against the backdrop of the continuing evolving situation of COVID-19.

Funding: In 2021 we continued to proactively access funding provided by the federal government through the wage subsidy program, and through the provincial government as it became available.

Stewardship: In lieu of our Stewardship campaign this year, we provided the congregation with an update, via email and regular mail, on our financial position to the end of October. We were very encouraged with the support that was received throughout the year, and reminded everyone of the opportunity for continuing their support of the work of the church during the final quarter. While Sunday services did resume late in the fall, attendance was limited as was the related in-person financial support that would normally increase with in-person attendance. At the end of the year, faced with increasing pandemic restrictions, we again moved to worship online.

Rental Contracts: Children's Choice was able to operate throughout most of 2021, and a new one-year contract was signed in August 2021. Apex Financial Solutions vacated their space, after appropriate notice, and another tenant was identified over the summer months. Juanita Wilson, a registered psychotherapist, is now occupying the space and providing counselling services. She has signed a one-year lease that will expire in August 2022.

Charity Return: The 2020 Charity Return with the Canada Revenue Agency was filed on time. There were no issues with the filing.

CRA Account: In 2020 our CRA (Canada Revenue Agency) electronic profile was created for the church so that we can access key tax and organizational information online and deposits can be received electronically from the government. We are also electronically filing our annual return and GST rebate.

Financial Results: As in prior years, The Exchange Group was engaged this year to perform the financial review. This is targeted to be completed in February 2022 and the statements have been included in this report. We ended the year with a surplus of \$38,339. This surplus includes \$13,000 for the Food Bank which will be expended in an upcoming year.

Our results this year were buoyed by federal and provincial COVID-19 support programs, a reduction of staff time due to the pandemic, a plant fund-raiser, the metal drive and the continued on-going support of the congregation. It should be noted that although we had a strong fourth quarter, overall giving was down approximately \$19,000 in the current year in comparison to 2020.

Budget: As in prior years our team prepared and reviewed the budget for the upcoming year. As part of that process, a draft budget was presented to Council for its review with ultimate approval by the Congregation. The key assumptions are outlined for your information and consideration on page 40.

While our financial situation has been good over the last two years with reduced expenses and Federal and Provincial government support due to Covid 19, we do have some significant concerns looking forward. This is reflected in our 2022 budget with a deficit of (\$48,929) projected in the General Fund. While we have enough financial reserves to deal with this in the upcoming year we will need to find solutions on a go-forward basis as our expenses continue to increase and our revenue has been decreasing. Over the next few months, we will need to put together a plan that allows us to move forward successfully over the long-term.

Team: Our team met regularly over the last year and included returning members The Reverend Carol Fletcher, Don Heinrichs, Adrian Measner, Donna Hadaller, Devan Ostapyk, Cindy Ostapyk and Jim Lewis (who continued to represent the trustees). We were also delighted to welcome Chris Richard and Barb Heinrichs to the team. An orientation education session was held in May for new and returning members.

THROUGH ANOTHER CHALLENGING YEAR THE CONGREGATION CONTINUED TO FAITHFULLY SUPPORT THE WORK OF OUR CHURCH.

Our Team for 2021 consisted of Karen Ilchena, Laura Fraser-Schau and new members Vivien Laurie and Sheilah Ross Campbell. Thank you to all members of the Team for providing the human resources function for TMUC as well as reporting to Council on a regular basis. Special thank you to Laura for her leadership as she resigned from our team in August.

With the ongoing pandemic, 2021 continued to be a very different yet busy year for TMUC and our Ministers Reverend Carol Fletcher and Reverend Jeff Cook, lay staff and volunteers. TMUC is very fortunate to have strong, dedicated and creative leadership in the team ministry of Carol and Jeff. Virtual ministry as we've worshiped from our homes has been embraced by our Ministers, music team, youth point person and countless other volunteers as they've worked together to prepare weekly services that are shared with our congregation and community. From weekly check-ins and services on YouTube, they also developed ZOOM communion services for face-to-face worship and implemented online Sunday School for our congregation's youth. We are truly thankful and blessed to be part of a congregation consisting of dedicated ministerial, lay staff and volunteers who make valuable contributions to the life and work of TMUC.

REGIONAL COUNCIL REPRESENTATIVE

Due to COVID-19 health orders and protocols opportunities for people throughout the Prairie to Pine Region to gather for in-person worship or meetings was limited. Members of faith communities in the Region were able to meet via ZOOM for updates and for mutual support and sharing. The Region's Pastoral Relations Minister, Rev. Judy Hare, regularly facilitated "Ministry Personnel support gatherings" also via ZOOM.

The Annual Meeting of the Prairie to Pine Regional Council was held via ZOOM from Friday, May 28 to Sunday, May 30. The theme was "Our Place in the Rainbow". Friday and Saturday the business of the meeting was conducted. Retirees were honoured, covenants were undertaken with some Communities of Faith, and admission of an Order of Ministry person from another Christian denomination was celebrated. Commissioners and alternates were elected for attendance to the 44th General Council in 2022. The Moderator's message was shared. There was worship time and Mission & Service moments. The most memorable presentation, "Our Journey as an Indigenous People" was extremely moving and informative. Through discussion of the four quadrants of the Medicine Wheel, Gloria Cook explained what life was like before contact, what occurred as a result of contact, and the destructive consequences of those actions. She concluded with the hope for empowering Indigenous Peoples to reclaim their identity, self-governance, and their spirituality and traditions. (Coincidentally, the news of the discovery of the 215 Indigenous children in an unmarked mass gravesite at the former Kamloops Residential School coursed through the chat on ZOOM during the presentation giving all participants pause to reflect on our sad past and to mourn those children, their families and their communities.)

On Sunday the meeting wrapped up with a service of celebration of Prairie to Pine Region becoming an Affirming Ministry, with communion and a time to make a joyful noise followed by a virtual Rainbow dessert party.

The Trustees continue to work closely with the Council and Teams and are very grateful to these individuals for their work, particularly during this unusual year. During the pandemic the Trustees have met only when urgently required to address emerging issues.

Financial Report

The United Church of Canada Loan:

- The loan at the UCC had a balance of \$74,480 on July 12, 2017 when the long-term arrangements were finalized;
- The interest rate is 2% with 10-year amortization
- As at December 31, 2021 the balance on the UCC loan was \$31, 077.

Building Funds

- At December 31, 2021 the Building Fund Chequing Account balance was \$40.68. And the Savings Account balance was \$89,950.
- Irrespective of the balance in the savings account, out of an abundance of caution due to the pandemic, the decision was made with Council to continue to make monthly payments on the loan rather than extinguishing it.

Ministry Fund:

At December 31, 2021 the total TMUC Ministry Fund balance was \$ 28,691.

Term Deposit:

 At December 31, 2020 the Term Deposit balance was \$ 36,353. This Term Deposit secures the line of credit for TUMC's General Fund. It earns interest of 2.1% and matures on August 17, 2025.

Other Highlights:

- The Trustees can confirm that property taxes were paid.
- The Trustees can confirm that there is appropriate insurance on the building and its contents. An inventory of contents is on file and will be updated in 2022.
- The Ministry Fund currently holds residual funds of approximately \$2,500 which were received as part of the funding for the Messy Church Canadian Conference which was

held on-line in the past year. We are awaiting direction from the United Church as to whether these funds need to be returned or set aside for future Messy Church activities.

BUILDING and PROPERTY TEAM

2021 was definitely a different year for the Building and Property Team. Usually, we meet monthly and review our requirements but this could not happen because of the Covid Pandemic. Somehow, the annual testing of the fire alarms, furnace fire inspections, checking the fire extinguishers, and the AED units (automated external defibrillator) etc were completed.

With the Food Bank, Nursery School and the odd Funeral happening, we continued to have the facilities cleaned weekly by Consumer Care Cleaning. We also had the floors stripped and waxed for the upcoming year. Other projects such as the changing of the lights in Yale Hall and the upcoming electrical in the kitchen were done. The aging office computer programs and internet were upgraded. The recycling program continued.

The following necessary repairs were done:

- -back outdoor ramp
- -office floor tiles replaced
- -mechanical repairs to the front door
- -plexi-glass "sneeze guards" were installed in the sanctuary due to Covid
- -repaired and replaced soap dispenser trays in all washrooms

Programs that are still pending:

- **-Asset Management** will allow us to make a complete inventory and replacement values of equipment. This will help in determining the appropriate amount of Church Insurance and also will help us track maintenance and costs.
- **-Federal Grant Application**: We have applied for funding from the *GREEN and INCLUSIVE COMMUNITY BUILDING PROGRAM OF NATURAL RESOURCES CANADA.* If we qualify it would help with some major environment upgrades to the church buildings, replacement of the aging furnaces, and sanctuary roof repairs.
- -Provincial Grant Application: In January 2022 we applied for a grant under Building Sustainable Communities program. If successful, this grant plus a contribution from the United Church of Canada Faithful Footprints program, will cover the costs for replacing two of our furnaces. If we are successful in getting both Federal and Provincial Grants the replacement of all of our furnaces will be covered.

The Building and Property team and generous members of our congregation helped with this busy year.

Crafting on a computer...a phrase that sounds kind of odd, yet that is what has been happening this past year.



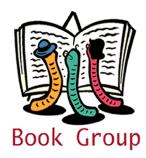

OUTREACH TEAM

On behalf of Outreach we are pleased to report that we have accomplished a few of our Objectives that were allowed due to restrictions due to COVID 19.

We met in-person at TMUC in November. We started planning a few ideas for our Objectives that we would like to achieve in 2022. These ideas will be placed on hold until the COVID19 numbers are reduced and life begins with the new normal.

Susan Sebastian continued on as Vice-Chair and Jack Puranen was voted in as Chair for the Transcona Food Bank, with Cheryl Freeman, Treasurer and Midge Barry, Secretary. All volunteers with the Transcona Food Bank have been fully vaccinated and most with their 3rd

dose. With the new rules being implemented in 2021, that only vaccinated clients would be allowed to enter the Food Bank. The unvaccinated clients are still allowed food. The volunteers would gather the food and then give it to the unvaccinated client who is waiting outside.

The Food Bank continued to run once a month per Manitoba Harvest guidelines. Averaging 75 families per opening and our Christmas opening we had seen 90 families. The Food Bank continues to purchase eggs and milk for 12 to 18 years old children, since Harvest Manitoba does not supply milk for that age group. They have also purchased canned food and hamburger/chicken chubs for their clients. The Food Bank received large donations of food and money at Christmas from the people, schools, and businesses in the Transcona area.

Age and Opportunity's Santa for a Senior Program was organized by Sue Sebastian and Food Bank's Secretary Midge Barry. The gifts were delivered directly to the clients. The ones that could not be delivered were delivered to the Transcona Food Bank for distribution. This program is for Seniors that do not have family and will not receive a Christmas present. It is open to all Seniors in Manitoba and Outreach facilitates this program for the Seniors of Transcona.

Mother's Day and Father's Day carnations were delivered by Shirley Bird to Park Manor Personal Care Home. Shirley was told by the staff of Park Manor that the flowers had brightened their day and were truly appreciated.

Carol and Jeff were providing Pastoral Care by telephone, video chats and a few in-person visits.

Holly Hill completed the weekly sending out of the Get Well and Sympathy cards with the names provided by Jeff and Carol.

The Senior's Meal Program has been running throughout the year providing their takeout service. The numbers vary and there has been several days that the number of orders reached over 100 meals being picked up. The Senior's Meal Program received a grant to purchase a convection oven, steamer cabinet and portable induction unit. The electrical additions will be completed and the equipment should be received in January, 2022. This equipment will make it easier for the Chef Steven and his staff to prepare all the delicious meals.

TRANSCONA FOOD BANK

The year of 2021 was a year where we continued to deal with the challenges of Covid and even more changes as to how the Food Bank operates.

In February we received the United Way Grant which we purchased 38 duffle bags for a cost of \$2,952.20 from Canada Luggage Depot. These were given out to our clients who had no grocery carts/wagons to help take their food home. They also gave us 38 waist safes as a gift. The remaining Grant money of \$600.00 was given to TMUC to go towards the cleaning of the building.

Under a grant we were still supplying taxis for those clients who walk home in the months of January, February, and March. The committee decided to extend the taxis for April and May. The cost of this was taken out of our TFB bank account.

In May the Transcona Food Bank had the honor of being the recipient of the Casera Credit Union 2021 Community Enrichment Award. Susan and I accepted the award on behalf of the food bank.

In May Harry Doucette made the decision to step down from the committee, he will still continue his other volunteer duties with us. We thank Harry for all his years of service to the committee. We welcomed Pat Johnson as our new committee member.

In June the Hi Neighbour Parade was cancelled again this year due to Covid. The Transcona Biz refunded our money for cost of the Reader boards located on Regent and Plessis at Dugald.

In September we renewed our annual Honorarium of \$400 we provide to TMUC to help out with costs the church incurs in housing our Food Bank.

In September our executive council was re-elected for the 2021-2022 year:

In October we had a Freshco Fund Raiser. The Freshco store located on Regent and Lagimodiere held a food drive on Thanksgiving weekend October 8 - 11. They also were collecting cash donations for the Food Bank from October 4 to October 24th. We set up a table staffed by our volunteers for the weekend. We received \$668.65 in cash donations at our table and Freshco collected \$1,025.68 at the cash registers.

Grand total was \$1,697.65. Freshco gave us \$1,025.68 in Freshco Gift Cards. The food that they collected for us was valued around \$2,235.00. We received well over 350 hamper bags of food from them. We were told by Freshco that this could become an annual event. That is wonderful news for us. Thanks to the many volunteers who came and sat at the table.

Our Volunteers Appreciation Luncheon was held on October 28th. 28 people attended and all had good food and fellowship (Due to Covid only volunteers attended).

TFB received a call from Harvest Manitoba informing us that the Oakbank Food Bank has been closed due to the lack of volunteers during the Covid 19 pandemic. They asked if we would consider taking their clients from Springfield Municipality (Hazelridge, Anola, Oakbank, and Dugald). The TFB agreed to accept the country clients until another food bank is setup in their area.

On Wednesday November 10, 2021 the TMUC church council approved a policy that full vaccination is required for any person entering TMUC for any purpose. Food Bank Clients that have not been vaccinated will wait outside while volunteers pick up the food items. The volunteers will bring the collected food out to them so they can fill their own bags.

The Healthy Together Now Grant was approved for \$387.00 to help towards the purchase of mobile shelving for the food bank. The cart was purchased and is in use at the present time. We held our Christmas opening on Dec. 23, 2021. It was a great success thanks to the hard work of all of our volunteers. We had 90 families show up. This was the highest number for all of 2021 openings. Thanks to Susan and Stephen McKendry-Smith we had Christmas Music playing in the hall. Thanks also to the Transcona Railer Express Major Junior Hockey Club for their assistance in helping out the food bank. It is their 10th straight year of participation with us in the months leading up to Christmas.

A special thanks to Midge for all the hard work she has put in making this Christmas opening a success. This year we received generous food donations from schools, businesses, churches and several different organizations. We received a total of 69 donations for the month of December. It was wonderful to have all this extra food to give to our clients at Christmas. This was the most donations we have ever received in December since the Food Bank was started. We have received over 130 donations of clothing, food, toys and monetary from different sources this year. We are very grateful for all the help we have received from our Friends and Supporters.

With increased donations to our Food Bank in 2021, we have been able to spend more on extra groceries for our recipients. We buy milk and eggs for every opening. We have bought frozen hamburger, chicken, Stove Top Stuffing, Cranberry Sauce and pizzas as special items from time to time. We have also bought non-perishable cans when we run low in a particular category, especially when we observe lean times at Harvest Manitoba, which has been more frequent this past year.

GIFTS OF GRACE STREET MISSION (SPECIAL INTEREST GROUP)

The Gifts of Grace Street Mission was founded under the umbrella of St. Saviour's Anglican Church, 690 Munroe Avenue, Winnipeg. Since 2012, the Gifts of Grace Street Mission has been approved by the TMUC Council as a Special Interest Group. We thank our church members for all they have done, and continue to do to help keep this Mission vibrant and thriving; especially during these trying times of this pandemic. Your donations of toiletries, knitted items, clothing, socks as well as monetary donations are extremely appreciated.

The Mission's mandate is to provide Food, Friendship and Compassion to our Homeless Friends of Winnipeg.

The Mission started off 2021 under a health restriction due to the Covid-19 virus and therefore were not operating, but getting very anxious at getting out there the best way we could and serving our street friends who needed us. We brainstormed, and with Zoom meetings, we began organizing teams from our volunteer list to make sandwiches; which started at the beginning of February, 2021. These crews, along with the existing crew that had continued to make 300 sandwiches weekly since May, 2020, were able to supply Main Street Project with 700 sandwiches each week from Monday through to Sunday as well as 300 sandwiches going to Agape every Tuesday. We also were able to deliver 50 sandwiches for Red Road Lodge as well.

The casserole activity started up February 8 with one crew (the TMUC Crew) making 6 casseroles every 2 weeks for delivery to two Manitoba Housing Resource Centres; one on Plessis Rd., and one on Keenleyside in Elmwood. Along with the casseroles were included donations of juice boxes, cookies, wagon wheels, homemade muffins and buns which were donated by TMUC members, as well as Blessed Sacrament members and friends of our many volunteers. Another crew (the St. Saviour's Crew) was making and delivering 2 casseroles weekly to Agape. By the middle of June, it was decided that the TMUC Crew would discontinue this service due to volunteers having other obligations. This Crew made 67 casseroles during this time. These casseroles were very much appreciated and well received! The St. Saviour's Crew were able to continue to make two casseroles every Tuesday that were delivered to Agape along with sandwiches. Also, very much appreciated and well received!

With health restrictions opening up some, our regular casserole activity, headed by TMUC volunteers, resumed their regular duties and made 12 – 15 casseroles every two weeks. We started September 9th and continued every two weeks until December 22nd, when once again we were shut down due to the pandemic. There were 137 casseroles made during this period.

During the time when our Mission was able to go out to serve, the Gifts of Grace Street Mission had five different Thursday crews of volunteers, headed by St. Saviour's serving sandwiches and casseroles to our street friends and a crew that went out to serve on Sunday mornings during that time as well. Starting November 4th, the volunteers who served moved indoors to the new facility (where the old Mitchell Fabric used to be) and continued serving every Thursday and Sunday until the executive of the Gifts of Grace Street Mission made a decision, out of concern for our volunteers who were serving, that the health risks were too high and they cancelled in person serving outings until further notice. Beginning on December 23rd, and continuing weekly on Thursdays and Sundays, the food is delivered for service by Main Street Project staff to our homeless friends.

We have not been able to hold our Annual Volunteer Appreciation Evening; our Annual BBQ or our Pizza Mondays since the pandemic began. The Annual Volunteer Evening was usually held at the end of June; the Annual BBQ usually held in mid August and Pizza Mondays were, of course, on Mondays. We are all looking forward to getting back to enjoying these special events as soon as the pandemic is under control. Covid-19 also impacted our group from getting together in person for meetings. We did manage to get two meetings in; August 12th and November 1, 2021. We communicated a lot via email and also had a number of Zoom meetings to keep us all connected. Thank goodness for technology!

St. Saviour's Anglican Church provides tax receipts for anyone who may wish to make a donation to our Mission. Cheques are made payable to St. Saviour's Anglican Church with "Gifts of Grace" specified on the front of the cheque. We are truly blessed to have three congregations working together, plus several friends of the Mission to make our Mission what it is; even while dealing with health restrictions and the on again; off again running of our beloved Mission. We look forward to getting back to serving our patrons on a weekly basis as soon as it is safe to do so. Until then, we will do what we can from a distance.

Once we are able to safely start up again, we ask that anyone who wishes to donate clothing and non perishable food items use our drop-off spots, which are:

Once burnt meant twice shy so we decided to play the long game by postponing any decision on reviving the show to August 2021.

The year seemed to fly by and when August arrived we had hopeful discussions about a late fall production or more likely performances in April of 2022. To pull that off we required a full cast and a replacement for the producer position and so the call went out and most of our cast and crew responded with a resounding "YES". That left us with a couple of key roles to fill so we had set a cut off date of September 5 and pleaded our case with the congregation. In the end, though we didn't fill all the positions, enough were filled to really tempt us to move forward with April 2022 performances. However, when we took our emotions out of the discussion, we realized there were too many other deadlines and requirements to meet to make this season a go. Reluctantly a decision was made to cancel the 2022 season. In hindsight, it was the right thing to do.

With that tale of woe behind us I can't say it was all bad news. In fact, we recruited almost an entire family into our theater group. I am happy to close this report by welcoming back Russell Antymis to our cast, welcoming David Antymis to our light and sound crew and, last but certainly not least, welcoming Kathy Antymis into the role of Producer, Caught in the Act Co.

The Transcona Council for Seniors Inc.

The Transcona Council for Seniors Inc. is one of ten councils within the City of Winnipeg. The primary role is to assist seniors to remain living independently for as long as possible. The Transcona Council for Seniors Inc. provides information and referrals to community seniors as well as identifying and facilitating services needed to meet the needs of Transcona seniors.

Transcona Memorial United Church is a wonderful partner and provides space for the council for many of our programs and continues to be a safe port in the midst of storms and there have been many storms since March of 2019.

We use the church twice a week to provide our 55+ Dinning Experience to anyone who is 55 years of age or older. All meals for the past year have been take out or delivery. The meals are nutritious and in these difficult times just the friendly "Hello" when picking up a meal or having one delivered can add a bit of cheer to an isolated senior. If you need assistance with preparing meals you can order a meal Mondays and Wednesdays for pick up or delivery (for those unable to pick up a meal themselves) at 3:30 PM – 4:00 PM. We prepare about 100 meals per week. Our volunteer base in this program has been drastically reduced as we have tried successfully to keep social distancing guidelines and numbers of people together as small as possible.

Once a month we use Knox Lounge for the Alzheimer's Caregivers Group. This group has not been operating during 2021 but has resumed in 2022.

PickleBall has not been operating in Yale Hall during 2021 but again we hope to be able to start playing again in 2022.

We have received several grants to purchase a convection oven, proofer and two induction hot plates. This equipment will be installed in the kitchen in early in 2022.

The Transcona Council for Seniors Inc. has continued to operate during this very trying time and we look forward to continuing our partnership with TMUC with the hope that one day very soon it will be safe to resume our dine in program.

Thank you for being such a wonderful welcoming and generous part of our community.
