#### 6. <u>Approval of Minutes</u>

The Secretary noted a correction to the Minutes. Under Nominations, Barb Heinrichs and Chris Richard were nominated to the Administration and Sharing Team.

MOTION: Moved by Susan Copeland/Elaine Trochim, "That the minutes of the 68<sup>th</sup> Annual Congregational Meeting dated Sunday, March 7, 2021 be accepted as corrected." CARRIED.

7. In Memoriam

The In Memoriam list on page 9 of the Annual Report was read by Rev. Carol Fletcher and Rev. Jeff Cook during the service that preceded the Annual Meeting.

#### 8. <u>Celebration of 2021</u>

Audrey Lumsden noted that the Annual Report included reports from Trustees, Council and Teams and the accomplishments of the church groups and community groups for 2021.

**MOTION:** Moved by Cathie Morgan-Matula/Michelle Lamoureux, "**That we** receive all reports as printed in the Annual Report, pages 1-5, 10-37."CARRIED.

9. Old Business

<u>Environmental Policy</u> - Stephen McKendry-Smith provided some background on the draft Environmental Policy. The Policy was to have been presented at the 2020 Annual Meeting which was delayed due to the COVID pandemic. He noted that the Building and Property Team was trying to make environmentally friendly choices. He then reviewed the Policy. The Policy also includes an Environmental Co-ordinator to lead the decisions and to look for funding possibilities. In the discussion it was noted that the lighting in Yale Hall has been replaced with LED lights. The furnaces need to be replaced and they are looking at ultra-high efficiency furnaces or heat pumps as well as right-sized furnaces. A new roof for the sanctuary is needed and we are looking at extra insulation. We have applied for a grant but have not heard back as yet. There is a provincial grant that we have applied for as well as the Faithful Footprints program of the United Church of Canada. Stephen McKendry-Smith was thanked by the congregation for all his work.

MOTION: Moved by Karen Ilchena/Alan Gershuny, "That we accept the Environmental Policy and that Stephen McKendry-Smith be appointed the Environmental Co-ordinator." CARRIED.

#### 10. <u>New Business</u>

<u>Date of Annual Meeting</u> – Audrey Lumsden noted that the annual meeting has been held in March for the past few years.

MOTION: Moved by Anne Hruda/Mave Dickson, "That the date for the Annual Meeting be moved from February to March." CARRIED.

Ukrainian Flag

**MOTION**: Moved by Cathie Morgan-Matula/Linda Antymis, "**That we place a** paper Ukrainian flag in the window of the church." CARRIED.

11. Financial Results for 2021

Cindy Ostapyk advised that the Financial Statement in the Annual Report indicates a surplus of \$38,000. After review by the Exchange Group, the auditors, one adjustment was made and the surplus for the year is \$39,899. Revenue for the year is down and expenses are steady. We also benefitted from wage subsidies during the pandemic, the church being closed and there being no office administrator for the period.

MOTION: Moved by Cindy Ostapyk/Donna Hadaller, "That the Financial Statements for 2021 be accepted." CARRIED.

12. Appointment of Auditor

MOTION: Moved by Cindy Ostapyk/Anne Hruda, "That the Exchange Group be retained as auditors for the 2022 fiscal year." CARRIED.

Audrey Lumsden led the thanks to Cindy Ostapyk, the Administration and Sharing Team and Lynn Measner for their work with the finances, the Music Team, and the ministers for their work during this difficult time. She also expressed thanks to all the people who volunteer to keep the church functioning.

#### 13. Looking to the Future

Carol Fletcher reflected on coming back to our in-person worship and activities following two years and remote ministry, weekly zooms, and many phone calls

and restrictions on our activities. We do not know what the future will hold as we are living in an unpredictable world. In the unpredictability, we are still the church. This time of re-gathering provides us with the opportunity to think about, to envision, and to re-envision, how we continue to live our share of Christ's ministry in a world that has changed and is changing. Council will be meeting soon to consider how we look towards the future.

#### 14. Approval of Proposed 2022 Budget

Adrian Measner advised that for the General Fund the assumptions for the proposed Budget were that it would be a normal year. That was not the case for the first part of the year. Givings were based on 2019 and adjusted for a decline each year. Fundraising was based on our normal fundraising activities. There will not be a Dinner Theatre this year. We will not be receiving the wage subsidies that we received last year. An increase of 1.3% for pastoral care and an increase for hydro expenses were included but hydro may go up even more as well as other expenses due to inflation. A \$49,000 deficit was determined in November but we did not have a good start. There is a \$6,800 deficit for January and February and there will be additional expenses for the office administrator and building expenses going forward. A process to look at finances has been started. We can manage this year but cannot continue in this direction.

The Building Fund continues to receive donations. Expenses in the Budget include the payments on the United Church of Canada loan, our share of expenses for the furnaces and roofing based on the grant application and audio-visual equipment for the basement for when there are large funerals or the need to socially distance again. A deficit of \$17,000 in the Building Fund is indicated but this is not a problem as the expenses are not continuing expenses.

The Ministry Fund continues to receive small donations.

# MOTION: Moved by Adrian Measner/Vicky Low, "That the Proposed Budget for 2022 be approved." CARRIED.

Audrey Lumsden indicated that a meeting of Council is to be held March 22, 2022 to look at ways for moving forward with the deficit. A committee may be set up. Audrey Lumsden thanked everyone who worked on preparing the Proposed Budget.

15. Nominations

<u>Trustees</u> - Audrey Lumsden advised that letters of resignation from the Trustees have been received from Errol Hendricks and Julia Brooks. She noted that both individuals have been long-time workers in the church.

# **MOTION:** Moved by Bob Kirkhope/Linda Antymis, "**That we accept the resignations of Errol Hendricks and Julia Brooks from the Trustees**."**CARRIED**.

Audrey Lumsden advised that Gail Purcell was nominated to serve as a Trustee.

# MOTION: Moved by Anne Hruda/Mave Dickson, "That Gail Purcell be accepted as a Trustee." CARRIED.

<u>Council</u> - Audrey Lumsden advised that Breanna Drennan-Bilyk was nominated to serve as Chair, Marcel Van Eerd was nominated to serve as Chair Elect. Norine Hochkievich has resigned from the Worship and Welcome Team. Laura Fraser-Schau and Cathie Morgan-Matula were nominated to serve on the Worship and Welcome Team.

MOTION: Moved by Alan Gershuny/Ken Wilkie, "That the nominations as presented be accepted." CARRIED.

There were no further nominations.

Audrey Lumsden indicated that she would continue as Past Chair and thanked all Council members.

16. Other Business

Following a question about printed annual reports, it was noted that anyone who wanted a printed copy should contact the church office.

We discussed, briefly, the church's involvement and response to other important events such as the discovery of unmarked graves at residential schools and Black History month.

It was agreed that we would individually say a prayer for peace, thinking of the invasion of Ukraine, at 6:00 p.m. each day. This invitation to prayer will be shared through our church news and social media.

The congregation thanked Audrey Lumsden for serving as the Chair for such an extended period.

MOTION: Moved by Audrey Lumsden/Marcel Van Eerd, "That all people present who are not Council members and/or trustees, are able to speak, make motions and vote at this meeting." CARRIED.

#### ROOF REPLACEMENT AND INSULATION UPGRADE:

Stephen McKendry-Smith brought forward the recommendation from Building and Property Team to replace the shingles on the Sanctuary roof, build a bridge roof between the choir room and the CE Building, repair the roof over the Sanctuary entrance/balcony, blow cellulose insulation into the existing rafter chambers and add one layer of 2-inch Enerfoil board to the surface of the roof at a cost of \$153,200 as outlined under Option 3 of the Roof Replacement and Insulation Upgrade Report dated July 25, 2022. He then did a presentation on the report that was made available to the congregation. This work will raise the R-value from R-7 to R-25. He noted that the roof needs to be repaired this year and as the shingles are expected to last 35-50 years this is our only opportunity to increase the insulation for many years. He noted that the furnaces in Suthwyn Hall will need to be replaced next year and with the extra insulation we should be able to reduce the furnaces from four to two.

A discussion then followed. Above All Roofing is able to do all aspects of the project. Matula Roofing will also be doing the flat roof of the CE Building. We have a grant of \$10,200 from Efficiency Manitoba and have applied for a \$50,000 grant which has not been approved yet. We have a bequest of \$30,000 which can be placed in the Building Fund. We currently have \$100,000 in the Building Fund, \$27,000 of which is earmarked for the United Church loan for the renovations to the building. Upon approval of the Prairie to Pine Region, the trustees will be able to ask the United Church to roll back our loan by \$60,000 at a reduced interest rate. Adrian Measner advised that we will have about a \$20,000 deficit at the end of July. We will have a projected deficit at year-end of \$30,000 which is less than the \$47,000 deficit in the budget. He noted that we do need to manage our finances and that a five-year plan would be beneficial.

MOTION: Moved by Stephen McKendry-Smith/Bob Kirkhope, "That TMUC undertake the required repairs to the roof and proceed with the roofing replacement and insulation as outlined in Option 3 brought forward by the Building and Property Committee in its report dated July 25, 2022."

Stephen McKendry-Smith was thanked for all his work on the project.

**MOTION**: Moved by Alan Gershuny/Audrey Lumsden, "**That the congregation of TMUC confirm the request to increase the United Church Ioan by \$60,000**."CARRIED.

**FINANCIAL UPDATE**- Cindy Ostapyk reported that for the first six months we have a deficit of about \$16,000. This was helped by a donation of \$10,00 and two fund-raisers. She thanked everyone who had contributed and encouraged participation in upcoming events and for support with givings to manage the funds for the year. She also noted that a strategy needs to be developed to manage our costs over the next few years.

#### PROCEDURAL MOTION:

**MOTION**: Moved by Ken Wilkie/Don Heinrichs "**That all members and adherents are able to speak and vote at this meeting.**" CARRIED.

#### NEW BUSINESS:

<u>Community of Faith Profile</u> – Breanna Drennan-Bilyk advised that this meeting is being held as part of the formal procedure for a change in ministerial staff. Adrian Measner provided an outline of the Financial Review portion of the documents that were required. The financial review covers seven years of information including revenue, expenses, bank balance and age of givers. Gail Purcell reviewed the Community of Faith Profile and noted that the job descriptions of the Office Administrator and the Congregational Designated Ministry Position (Youth Point Person) are also included. Lynn Measner reviewed the recommendations from the Ministry Profile Team that were accepted by the TMUC Council.

A discussion was then held. Items raised included the salary range, changes will be required in going from 1  $\frac{1}{2}$  ministers to 1 minister, the need for a tech person as well and the need for a building management position. It was noted that we should see what unique skills and resources the new minister will bring. Breanna Drennan-Bilyk then read the two other procedural actions to also be included in the first motion.

**MOTION**: Moved by Marcel Van Eerd/Ann Cooke,

"There be a reduction in ministry time from 1.5 Ordered Ministry Positions to 1 FTE

Recommendation that the staff include a Congregational Designated Ministry Position (Youth Point Person) at 7.5 hours per week to be hired after the Ministry Personnel is in place and can be involved in the hiring.

We proceed with the posting of a full time (40 hr/week) ministerial position effective July 01, 2023 for Transcona Memorial United Church, according to the terms of employment: (included in the Ministry of Faith Profile).

That Gail Purcell be appointed to forward all required documents (Profile including Living Faith Story, Position Description, Financial Viability Review, 2021 Year End Financial Statements, Year to Date Financial Statements in 2022, documents related to CDM position, minutes containing motions) to the Pastoral Relations Minister in a timely manner for final approval by the Pastoral Relations Commission no later than December 2, 2022 and Lynn Measner be appointed to post the Profile on Church Hub after final approval by the Pastoral Relations Commission."

Breanna Drennan-Bilyk then read the second motion to be accepted that refers to the Search Committee. She advised that she had looked for people who would provide a wide range of perspectives and looked at service in the church, outreach, affirming, and length of time in the congregation and community. Nello Altomare, Jessica Blaikie-Buffie, Joy Chand, Kevin Drennan and Audrey Lumsden have agreed to serve on the Committee. A discussion then followed.

MOTION: Moved by Bob Kirkhope/Alan Gershuny, "That the following people be appointed to the Search and Selection committee of Transcona Memorial United Church to act after training on January 7, 2023: Nello Altomare, Jessica Blaikie-Buffie, Joy Chand, Kevin Drennan, and Audrey Lumsden." CARRIED.

Rev. Mary Best and Ann Cooke left the meeting at 7:55 pm and Rev. Carol Fletcher and Rev. Jeff Cook rejoined the meeting.

**FINANCIAL REPORT**: Cindy Ostapyk reported that the deficit to the end of October is around \$21,700 which is better that projected in the Budget. A letter will be sent to the congregation with financial information as there will not be a stewardship campaign this year. She also advised that Council has developed a Multi-year Plan to keep on top of the financial situation and challenges over the next five years. This information will be shared with the congregation along with the Budget information. She thanked everyone for their support.

# MESSAGE FROM THE CHAIR OF THE COUNCIL

Greetings and blessings be with you always.

In 2022, Transcona Memorial United Church continued to be a community hub despite starting the year under pandemic restrictions. As a welcoming church, we truly did our best to seek justice, foster and nurture growth by teaching, worshipping, through music, sharing and being welcoming to all while continuing to observe the health orders set out by the province of Manitoba. We continue to live out our mission and vision:

to be an evolving, welcoming and sharing community church with a community presence. We celebrate the diversity of God's image present in all people. We embrace the diversity of abilities, ages, appearances, family configurations, gender identities, gifts, life experiences, races, sexual orientations, and talents. We welcome the full participation of people, in all of their diversity, in the whole life and work of the congregation. In Christ's name we share God's love as people of varying economic, educational and physical situations. We remain open to God's spirit deepening our faith and our love.

# ADMINISTRATION and SHARING TEAM

Like all other teams, the Administration and Sharing team had another interesting year in 2022.

It has been wonderful to see our congregation start returning to normal activities and to witness the support for our projects big and small. Thank you for your continued financial support and the contributions of time and talent as we jump-start the work of our church.

**Funding:** In 2022 we saw reduced financial support from government as the country moved out of the pandemic and moved back to more normal operations.

**Stewardship:** In lieu of our Stewardship campaign this year, we provided the congregation with an update, via email and regular mail, on our financial position to the end of October. We were very encouraged with the support that was received throughout the year, and reminded everyone of the opportunity for continuing their support of the work of the church during the final quarter, and into the 2023 budget year.

**Rental Contracts:** New two-year contracts were signed with Children's Choice and Juanita Wilson, a registered psychotherapist, who has been our tenant for one year. Increases, that reflect increases in TMUC operating costs, were incorporated into both contracts.

**Tip Tap:** In 2022 TMUC implemented the use of a Tip Tap machine that allows contributions to be made via credit card at church events. This technology has been used at Messy Church and fund-raising events. The net benefit to us in the past year has been \$460. We look forward to continuing use in 2023, as more congregants get familiar with the device.

**Charity Return:** The 2021 Charity Return with the Canada Revenue Agency was filed on time. There were no issues with the filing.

**Financial Results**: As in prior years, The Exchange Group was engaged this year to perform the financial review. This is targeted to be completed in February 2023 and the statements have been included in this report. We ended the year with a deficit of \$(2,085). Although fund-raising activities were held during the fall, the winter and spring was challenged with COVID-related curtailments and limited government support.

Our results this year were strengthened by the contributions through the on-going work of our funeral hosting team and through various individual projects that included a plant fund-raiser, a metal drive, a book and rummage sale, the auction, a trivia night and a mystery evening.

**Budget:** As in prior years our team prepared and reviewed the budget for the upcoming year. As part of that process, a draft budget was presented to Council for its review with ultimate approval by the Congregation. The key assumptions are outlined for your information and consideration on pages 54/55.

Our budget for 2023 reflects the transition to one minister in July of 2023, and associated costs of recruitment. While this change will help our financial situation in the short term, it is important that we remain vigilant going forward. To that end, the Council has been developing and reviewing multi-year financial plans, that will be monitored on a regular basis.

**Team:** Our team met regularly over the last year and included returning members Reverend Carol Fletcher, Don Heinrichs, Adrian Measner, Donna Hadaller, Devan Ostapyk, Chris Richard, Barb Heinrichs, Cindy Ostapyk and Jim Lewis (who continued to represent the trustees).

During the year, the trustees accepted the resignation of Julia Brooks and Errol Hendricks with thanks. Their contributions will be sincerely missed.

The Trustees continue to work closely with the Council and Teams and are very grateful to these individuals for their work. Over the past year Trustees have met only when required to address emerging issues.

#### Financial Report

The United Church of Canada Loan:

- During the year we accessed additional funding of \$60,000 through the United Church of Canada, to finance necessary roofing repairs.
- Interest on the loan remains at 2%.
- As of December 31, 2022, the balance on the UCC loan was \$83,244.

Building Funds

- On December 31, 2022, the Building Fund Chequing Account balance was \$344. And the Savings Account balance was \$108,212.
- To date, grants to support capital projects were received from:
  - Faithful Footprints (The United Church of Canada) \$29,000
  - Community Incentive Grant (City of Winnipeg) \$46,250
  - Building Sustainable Communities (Province of Manitoba) \$30,000
  - Efficiency Manitoba \$9,467
- Irrespective of the balance in the savings account, we continue to pay down the loan to make best use of our financial resources.

Ministry Fund:

• At December 31, 2021 the total TMUC Ministry Fund balance was \$ 30,376.

Term Deposit:

• On December 31, 2022 the Term Deposit balance was \$ 37,116. This Term Deposit secures the line of credit for TMUC's General Fund. It earns interest of 2.1% and matures on August 17, 2025.

# Other Highlights:

- The Trustees can confirm that property taxes were paid.
- The Trustees can confirm that there is appropriate insurance on the building and its contents with updated information provided through the United Church of Canada (UCC). Revised insurance arrangements are in the process of being finalized through UCC as they transition to a new process.
- The Ministry Fund currently holds residual funds of approximately \$2,500 which were received as part of the funding for the Messy Church Canadian Conference which was held on-line in the past year. We have verbal confirmation that we can hold this money in trust for future Messy Church Canada related activities.
- The Trustees are recommending updated Terms of Reference for the Building Fund which will be brought to the AGM for approval.

# **BUILDING FUND**

# Terms of Reference

**Purpose:** In recognition of the requirement for planning for future needs and overall good stewardship, Transcona Memorial United Church (TMUC) has established a Building Fund to receive funds to be used to support future development and renovations to the building and property.

**Use:** Specifically, the fund can be used for only three purposes:

- 1. For building expansion
- 2. For land and building acquisition
- 3. For other expenses related to building and property renovation and significant maintenance.

**Record keeping of Building Fund:** The contributions to this fund are accepted for a specified purpose, and must be accounted for separately from gifts to the general fund, with an appropriate donation history maintained by TMUC. The funds cannot be used for any other purpose.

Administration: The administration of the fund, including disbursements and investment, is subject to the control and discretion of TMUC Council, Trustees and Congregation according to the processes outlined in the United Church Manual and United Church of Canada Financial Handbook.

**Investment of Funds:** The Building Fund will be maintained in a separate bank account. The investment horizon for these funds is short (0-5 years), with a focus on maintaining capital and liquidity to appropriately support the needs of the Fund. Accordingly, the Fund will be invested in cash and cash equivalents providing reasonable liquidity and protection of loss of capital through the Canada Deposit Insurance Corporation or similar program or through investments issued by Federal or Provincial Governments or Crown Corporations.

**Income of these Funds:** All income from this fund must be retained within the Building Fund.

**Change in Use:** Any change in use of this fund must be approved by the Congregation.



# **BUILDING and PROPERTY TEAM**

Well, it's time again to report on the activities of the team. Like every year the Building and Property team has had a very busy and active and, in most cases, a satisfying year. We completed several projects including some contracting out.

With all the activities of the Food Bank, Nursery School and Meal Program, etc. during the day we still accomplished:

-upgraded lighting in Yale Hall

-coordinated the HVAC work including the installation of new furnaces in the west furnace room that services Yale and Springfield Hall

-renovations to the Food Bank room including the installation of electrical outlets to accommodate the new freezer

- the purchasing of two laptops and audio equipment for the streaming of TMUC services

-repaired/replaced the vandalized air conditioner on the outside eastern part of the building

-installed a rainbow flag on the front of the CE building affirming our faith community

-sanctuary organ was repaired

-coordinated a very successful metal drive

-reviewed the Five-Year Plan for the future major costs for the B & P team

-renewed the Five-Year contract for the internet/phone

-installed electric thermostats for Yale and Springfield Hall

-coordinated the stripping and waxing of both halls, hallways, and stairs

-modified the kitchen for the upgrading of the Meal Program equipment

-a major project was the replacement of the Church roof and the additional insulation of all parts of the building

Our Environment grant applications were successful with the replacement of our roof and two furnaces and will continue in the new year.

# THE TRANSCONA MEMORIAL UNITED CHURCH GREEN PLAN

#### Activities

In 2022, TMUC made good progress on our journey to reduce our carbon footprint, and to reduce our energy use. We completed three projects.

- Replaced three furnaces in the West furnace room with two 98% efficient gas furnaces, configured to allow the addition of cold climate air source heat pumps (ccASHPs) this spring.
- Installed two heat recovery ventilators (HRVs) to provide pre-conditioned fresh air to the building.
- Added insulation to the roof while replacing our worn-out shingles and doing other roof repairs.

Once the ccASHPs are installed this spring, our efforts will have reduced our carbon emissions by over 60%.

#### Fund raising

In 2022, TMUC received over \$120,000 in grants, donations, and rebates in support of our Green Plan. This includes contributions from

# Future Plans

We anticipate making much more progress on our Green Plan in 2023. We have received approval, in principle, for a federal grant of over \$450,000 to support our green initiatives. We will also be applying for another Building Sustainability grant and pursuing other funding partners to support us on our green journey.

These grants will support our plans for 2023, which include.

• Replacing the four furnaces in the East furnace room with two 98% efficient furnaces backing up two ccASHPs.

- Installation of two HRVs in the East furnace room.
- Insulate the walls in the East building.
- Renew the roof and add insulation in the West building.
- Install solar panels.

With the grants and rebates we have in place, and with those for which we've been approved, we should be able to accomplish all the above for about one-third of what the congregation approved for roof repairs alone.

On a personal note, I extend my heartfelt thanks to the Building and Property Team, the TMUC Council and Trustees, Carol, Jeff, and, of course, the entire congregation for your enthusiastic support of this Green Plan.

# WORSHIP and WELCOME TEAM

Thank you for all who are so welcoming – welcoming of people of all ages, experiences, sexual orientation, gender identity; welcome to people of varying capabilities, gifts, and perspectives; welcoming of those we have known for many years and welcoming of those who are relatively new to our community.

In 2022, we continued to worship and to welcome both in-person and via ZOOM and other forms of communication and social media. The committee met mostly on ZOOM with two meetings in person.

On Ash Wednesday we worshipped via ZOOM, offering Prayers for Peace, and inviting people to anoint their foreheads with oil. On Maundy Thursday we again worshipped via ZOOM, celebrating communion with a variety of breads baked by members of the faith community.

On Sunday, June 5 we joined with other Transcona churches to share in worship leadership at the Centennial Square as a part of the Hi Neighbour Festival.

In the summer months TMUC participated in 'Church-orama' as the faith communities of T'BJIGGN welcomed one another to worship.

On September 11, 2022 Sunday worship included a celebration of the 60<sup>th</sup> anniversary of the UCW and we dedicated a new banner to celebrate that occasion. For Orange Shirt Day we decorated the Sanctuary with orange handprints as we continued to consider and explore our place in a reconciling community.

We have added paper flowers made from hand tracings to the foot of the cross as a part of our prayers for Ukraine. #### **T'BJIGGN**

During 2022, the representatives to the T'BJIGGN cluster (Transcona Memorial, Birds Hill, John Black Memorial, Immanuel, Gordon-King Memorial, Grey Street, and North Kildonan United Churches) met via Zoom or in-person almost monthly. Our first planning endeavour was "Church orama" involving all the churches for worship over the summer. Since some churches did not have clergy support during the summer months, we created a plan that would encourage people from each church to visit other churches during July and August. TMUC and North Kildonan were blessed with clergy throughout the summer months and were able to be host churches three different times. We also encouraged churches to share the Advent candle lighting liturgy and hymn during their respective Advent worship services.

#### OUTREACH TEAM

On behalf of Outreach, I would like to inform Council, that we are pleased to report that we have accomplished our Objectives for the 2022 year. We met once in person for our meeting and the rest of our meetings were on Zoom.

The Transcona Food Bank has been running smoothly. We continue to wear masks for all Food Bank related events.

The executive for Transcona Food Bank is as follows:

Jack Puranen - Chair, Susan Sebastian – Vice-Chair, Cheryl Freeman - Treasurer and Midge Barry -Secretary. All volunteers with the Transcona Food Bank have been fully vaccinated and most with their 3<sup>rd</sup> and 4th doses. With the rules being implemented in 2021, that only vaccinated clients would be allowed to enter the Food Bank. The unvaccinated clients are still allowed food. The volunteers would gather the food and then give it to the unvaccinated client who is waiting in the foyer. Clients are now allowed to come into the building at 8:30 a.m. and will register and occupy the seating in Suthwyn Hall until 9:00 a.m. then they would be called to go through the food line. The Food Bank continued to run once a month per Manitoba Harvest guidelines. We are averaging 85 families per opening and at our Christmas opening we saw 126 families. The Food Bank continues to purchase eggs and milk for 12 to 18 years old children, since Harvest Manitoba does not supply milk for that age group. They have also purchased canned food and hamburger/chicken chubs for the holidays for their clients. The Food Bank received large donations of food and money at Christmas from the people, schools, and businesses in the Transcona area.

Age and Opportunity's Santa for a Senior Program this year did not happen for our Food Bank clients.

Mother's Day and Father's Day carnations were delivered by Shirley Bird and Holly Hill to Park Manor Personal Care Home. Shirley was told by the staff of Park Manor that the flowers had brightened their day and were truly appreciated.

Carol and Jeff were providing Pastoral Care by telephone, video chats and a few inperson visits.

Holly Hill completed the weekly sending out of the Get Well and Sympathy cards with the names provided by Carol.

The Senior's Meal Program has been running throughout the year providing their takeout service. The numbers vary and there have been several days that the number of orders reached over 100 meals being picked up. The Seniors Meal Program purchased the steamer cabinet and portable induction units that were installed in January, 2022. This equipment has made it easier for Chef Steven and his staff to prepare all the delicious meals.

#### TRANSCONA FOOD BANK

The year of 2022 was a year still dealing with Covid and the challenges we faced as we started to live with Covid and keep our food bank operating to feed families in need.

At our March 17 opening we welcomed four visitors from Harvest Manitoba; Vince Barletta - President & CEO, Grace Weigelt- Director of Peoples & Programs, Meaghan Erbus - Director of Community Food network and Advocacy and Jamie Antonowich - City Agency Liaison. Jack Puranen gave them a tour of the facility and explained how our Food Bank operates. Jack took them up to Knox Lounge to talk about what they had seen and discuss what Manitoba Harvest had planned for the rest of 2022. Photos were taken before they left. They were very impressed with how the Food Bank operates.

The Healthy Together Now Grant approved an additional \$ 600.00 for the purchase of thirty rolling carts for clients that did not have one.

The Transcona Food Bank applied for the Horizons Senior Federal grant. The following items that were approved under the grant were 1) Freezer ,2) 25 Client Grocery Carts, 3) Replace legs on delivery table, 4) Taxies for Clients, 5) Personal Hygiene Items, 6) Children & Adult Diapers, 7) \$1,500.00 to TMUC for cleaning of building. The grant expenditures start on March 30,2022 and end March 29,2023.

TMUC had to replace lighting fixtures in Yale Hall. The Transcona Food Bank donated \$400.00 to the church for lighting fixtures.

On May 4,2022 Jack and Susan Sebastian attended a Harvest Manitoba Town Hall meeting. Items talked about were Harvest Manitoba's plans for 2022 and we had a tour of their operations.

In June, the Hi Neighbor Parade was cancelled again this year. The Transcona Biz refunded our money for the cost of the Reader boards located on Regent Ave. and Plessis at Dugald.

On June 9, 2022 we held a Food Bank Volunteer Luncheon for our volunteers. Due to Covid only the volunteers and the TMUC ministers and office administrator were invited this year. A total of 41 volunteers attended.

On August 10, 2022, the Kildonan Green "Circle K" Store held a Hot Dog fundraiser for the Transcona Food Bank. They raised \$910.00 for our food bank. Amarinder Kaur and Hargurbir Singh hosted the fund raiser.

At our September 1,2022 meeting we had the election of Officers. The followingOfficers were elected by acclamation for the 2022-2023 year:Jack Puranen -ChairpersonSusan Sebastian - Vice-ChairMuriel (Midge) Barry - SecretaryCheryl Freeman - Treasurer

In September we renewed our annual honorarium of \$400.00, which we provide to TMUC to help with costs that the church incurs in housing the Food Bank.

The Food Bank received a 2 ft by 5 ft vinyl banner which reads Transcona Food Bank that was donated by Intergraphics Decal. This banner will be put to good use at our various events.

The Transcona Food Bank also purchased three more shopping carts from the Restore Store. This will help us out. The food bank also purchased a new chest freezer, which is located in the food bank room. This will help us by giving us more room to keep frozen food.

On Thanksgiving weekend Oct 7 to Oct. 8,2022, the Freshco Store held a fundraiser for the Transcona Food bank. We received 127 hamper bags worth \$835.00. We also collected \$443.90 in cash donations along with a gift card totaling \$183.50 from Freshco. We had volunteers sitting at the door for those two days. Special thanks to those who came out to help at the table.

Special thanks to Midge for all the hard work she has put in, making the Christmas opening a success. We had a total of 121 families at the Christmas opening. This year we received more food donations from schools, businesses, churches, and several different organizations. Also thanks to Susan for making sure we had Christmas music for the Christmas opening.

With increased donations to our Food Bank in 2022, we have been able to spend more on extra groceries for our recipients. We buy milk and eggs for every opening. We bought frozen hamburgers and stove top stuffing, cranberry sauce, pancake mix and syrup along with peanut butter and cereal as special items from time to time. We also bought non-perishable cans when we ran low in a particular category, especially when we observed lean times at Harvest Manitoba.

#### GIFTS OF GRACE STREET MISSION (SPECIAL INTEREST GROUP)

The Gifts of Grace Street Mission was founded under the umbrella of St. Saviour's Anglican Church, 690 Munroe Avenue, Winnipeg. Since 2012, the Gifts of Grace Street Mission has been approved by the TMUC Council as a Special Interest Group. We thank our church members for all they have done, and continue to do, to help keep this Mission vibrant and thriving, especially during these trying times of this pandemic. Your donations of toiletries, knitted items, clothing, socks as well as monetary donations are extremely appreciated.

# The Mission's mandate is to provide Food, Friendship and Compassion to our Friends who are experiencing homelessness in Winnipeg.

The Mission started off 2022 again under health restrictions with the Covid-19 virus still very much around us. With having our sandwich and casserole making crews already set up from last year, as well as other obligations that the Mission had in place; we all knew what needed to be done. The schedules for both the sandwich and casserole crews were set up by those in charge on a monthly rotation and the volunteers were notified by email or phone calls. The various teams, made up of volunteers from the entire Mission, were able to supply Main Street Project with 700 sandwiches each week from Monday through to Sunday, as well as 300 sandwiches going to Agape every Tuesday and 50 sandwiches being delivered to Red Road Lodge also. At a meeting on May 18, 2022, which was due to the possibility of a shortage of volunteers, it was decided that the Mission would drop the delivery to Red Road Lodge as well as the casseroles for the Sunday outings until further notice but would continue to maintain our commitment to our core business including the Van Patrol sandwiches.

The casserole crew started up in early January and by the end of December,2022, they had made 180 casseroles that were served or delivered to Main Street Project every Thursday throughout the year. There were several volunteers from St. Saviour's who served the casseroles and when it wasn't safe due to the virus to serve in person; the casseroles were delivered to the staff at Main Street Project to serve the clientele. Along with the casseroles there usually were donations of juice boxes, cookies, wagon wheels, homemade muffins and buns, which were donated by TMUC members, as well as Blessed Sacrament members and friends of our many volunteers. The St. Saviours Crew were also making and delivering 2 casseroles weekly to Agape every Tuesday when they delivered the sandwiches.

We were not able to hold our Annual Volunteer Appreciation at the end of June; but we held the Annual BBQ on August 4, 2022. This was the first BBQ that we had since before the pandemic started. Due to the virus still around, we scaled back some of the items that were usually included in the BBQ. We did serve hot dogs, sandwiches, munchie mix, potato chips, fruit cups, homemade cookies, water, and Kool-Aid. We have a lady who donates 200 Dixie-cups every year when we have the BBQ and she made it happen this year again and they were a real hit! There was a huge crowd of our street friends in attendance.

St. Saviour's Anglican Church provides tax receipts for anyone who may wish to donate to our Mission. Cheques are made payable to St. Saviour's Anglican Church with "Gifts of Grace" specified on the front of the cheque. We are truly blessed to have three congregations working together, plus several friends of the Mission, to make our Mission what it is today. The Covid virus certainly has made it a real challenge to manage the everyday mechanics of running the Mission.

We are not taking clothes at this time; but anyone who wishes to donate non perishable food items, please use our drop-off spots, which are:

Duo tangs were circulated throughout the congregation and members signed up to provide a gift for family members. Carol Fletcher included different food donations in the bulletin each week. We bought laundry baskets and grocery bags for the food items and large gift bags for the wrapped gifts. The generosity of our congregation and local business was again amazing.

The Christmas Cheer Board had amended the required food items for the hampers. Turkeys have been taken off the list along with tea, coffee, hot chocolate, cake mixes etc. Each family had a choice of protein, and all the hams and chickens were all donated for our 10 hampers. We were able to include milk, eggs, cheese, margarine, oranges, frozen vegetables, potatoes, and onions from Sobeys, who gave us a huge discount. We watched for sales and included paper towels, toilet paper, laundry soap, Mr. Clean, toothbrushes and toothpaste, Kleenex, salt, and baking soda. We also had an amazing amount of beautiful hand made mitts and toques.

We had Lorraine Walton and Mave Dickson help sort and distribute the knitted items on Sunday after church to each hamper. The hampers were delivered by volunteers on a cold December 21, 2022, and we very much appreciated their time.

Children's Choice Nursery School also provided a hamper by purchasing gifts for our new Ukrainian family. We bought a chicken and extras for that hamper as well as extra items that had been purchased.

The evening of December 21<sup>st</sup> we received a Call from Carol that there were six more Ukrainian families who did not apply for a hamper. We had money left over and we went out and bought chickens and food items for these families. Sobeys graciously donated twelve more bags.

All extra food items and knitted items were donated to the Transcona Food Bank which were received with open arms.

As there were no Sunday School classes to sort the food or an extra room to build the hampers, we used the main office and Carol and Jeff's offices. With being without office staff this was feasible but certainly limited the number of hampers that could have been donated. A suitable lockable space will need to be discussed before 2023.
